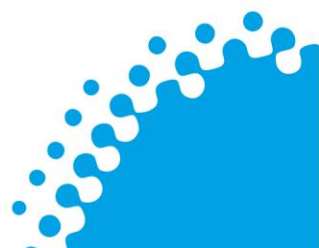

This Food Business Notification form is to be completed by each business selling food at the Gepps X Markets.

Once the form has been returned Council will forward a Laminated Gepps X Operator Card to the provided postal address shortly thereafter.

This Gepps X Operator Card needs to be displayed on the dash of your vehicle while entering and trading at the Gepps X Markets.

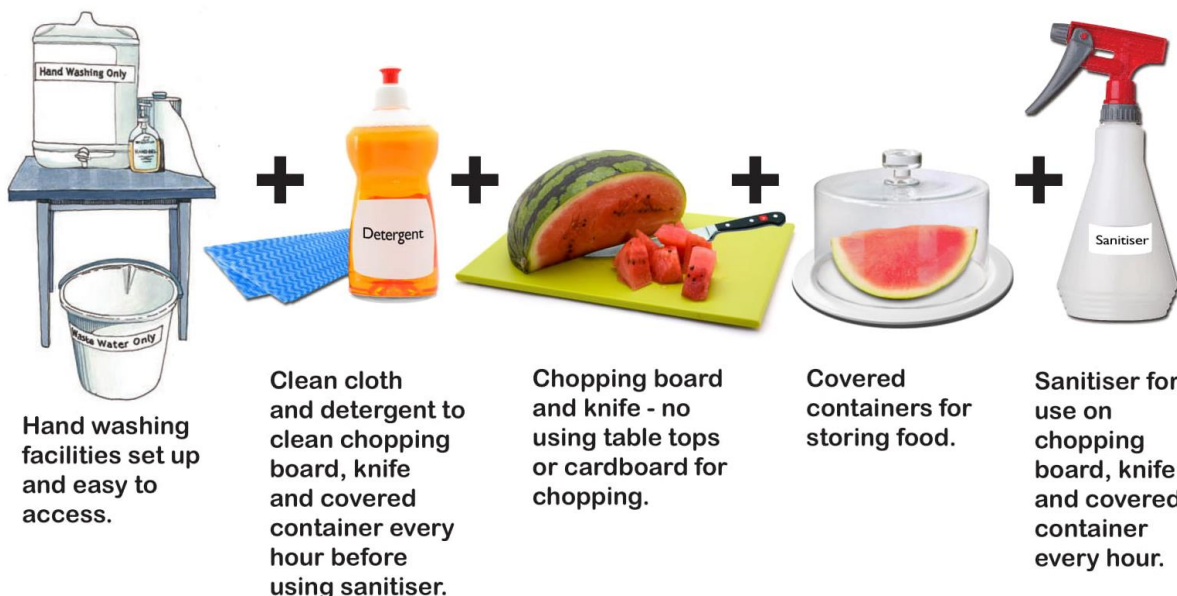
Please be aware that there is no fee associated with this process however the cards will need to be renewed annually.

## Additional Food Safety Information

If you are cutting fruit and vegetable products at the markets you will require additional materials to ensure compliance with the Food Act, please see below for information on how to ensure compliance with this requirement:

If you are selling potentially hazardous food, or food containing potentially hazardous food ingredients, you will have to ensure appropriate temperature control for this food during transport to and while trading at the markets.
