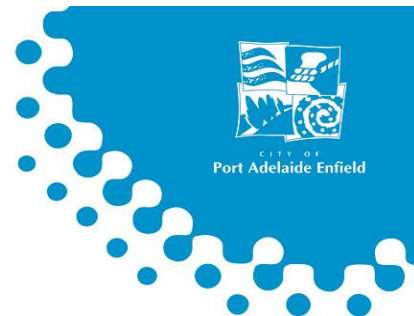


# COMMUNITY LAND MANAGEMENT PLAN



## Passive Recreation Reserves

### Kaurna acknowledgment

Acknowledgement and respect is paid to the Traditional Owners of the Land, the Kaurna People of the Adelaide Plains. It is upon their ancestral lands that the Land is situated. It is also The Place of the Kardi, the Emu, whose story travels from the coast inland. Respect is paid to Elders past and present and their spiritual beliefs and connections to land which are of continuing importance to the living Kaurna people of today. Acknowledgement is also given to the contributions and important role that Aboriginal people continue to play within our shared community.

### Purpose for Passive Recreation Reserves being held by Council

The land exists within a hierarchy of open space located throughout the City, used primarily to meet the recreational and wellbeing needs of the community.

### Objectives for the management of the land

- To provide an area for the use and enjoyment of the community where a range of recreation activities may be undertaken.
- To provide inclusive access to open space for the community.
- To support ecosystems, environmental management and storm water management.
- To support use of open space for short term activities, such as festivals, events and social gatherings.

### Proposals for the management of the land

Council's proposals for management of the Land are:

- Provision, maintenance, renewal and upgrade of assets including (but not limited to) buildings, car parking, drainage, water detention, lighting, footpaths, access roads, play grounds, furniture and landscaping
- Facilitation of programs, services and activities, including those undertaken by groups or organisations under a permit, lease or licence granted by Council
- Use of the land by individuals, groups or organisations under a permit, lease or licence granted by Council
- Installation and operation of telecommunications facilities under a lease granted by Council in circumstances considered by the Council to be appropriate and on terms reasonably satisfactory to the Council

## Policies and plans

Council will consider the terms of this Community Land Management Plan alongside other plans and policies which relate to the Land, including the following:

### Council policy

- 'Asset Management Policy' (TS16)  
Policy aims to guide the management of all public infrastructure assets owned, managed or under the care and control of Council within the Council Area to ensure that Council's services and infrastructure are provided in a sustainable manner, with the appropriate levels of service expected by residents and the environment.
- 'Public Lighting for Parks and Reserves' (TS11)  
Policy guides the provision of public lighting within all recreation reserves under the care and control of Council and particularly the infrastructure within the reserves, including (but not limited to) car parks, buildings, pathways and play-spaces, but not floodlighting to sports fields.
- 'Sustainable Environment – Discharge to Wetlands' (TS09)  
Policy to ensure the sustainable management of the City's marine and freshwater wetlands. Council does not endorse as part of any activity or development the direct discharge of wastewater, groundwater or other materials, including all chemicals, into Council-managed wetlands or in adjacent areas, where the release of such materials could directly flow or leach into the wetlands.
- 'Street Trees and Reserve Plantings Policy' (TS08)  
Policy applies to the planting and removal of trees on Council land and should be accommodated within the environmental and infrastructure constraints in public streets, reserves and on private property. Objective of the policy is to:
  - create an urban environment characterised by attractive and sustainable landscaping and useable open space throughout residential and commercial areas
  - improve the aesthetics of the living and working environment consistent with the environmental and infrastructure constraints in the public streets, reserves and on private property
  - contribute to the amenity and aesthetics of an area and to the well-being of its residents and visitors

### Council plans

- 'Asset Management Plans'  
These plans are comprised of the:

- Drainage Infrastructure Asset Management Plan
- Road Infrastructure Asset Management Plan
- Footpath Infrastructure Asset Management Plan
- Buildings Asset Management Plan
- Parks and Gardens Asset Management Plan

These plans guide the management of Council's assets and infrastructure, and interact closely with key strategic planning documents. These plans aim to predict infrastructure consumption and renewal needs and consider infrastructure requirements to meet future community service expectations. The plans set out the forecast capital requirements of the Council for the next ten years. These expenditure requirements are incorporated in Council's Long Term Financial Plan to ensure projected investment in infrastructure can be accommodated without detriment to Council's financial sustainability.

- 'Biodiversity Management Plan 2016- 2020'

The Plan focuses on indigenous vegetation and native animal protection, reserve and street tree enhancement and specific ecosystem and habitat restoration, where Council can play a role. A key strategy is to map, monitor and analyse biodiversity conditions to assist Council to maintain, restore and enhance biodiversity value.

- 'City Plan 2030'

An outward looking strategic document that represents community driven expectations which identifies the objectives for the City. The Plan's vision is: "A city that values its diverse community and embraces change through innovation, resilience and community leadership". The Plan establishes five key areas that are important: our economy, our community; our environment; place-making and leadership.

- 'Disability Discrimination Action Plan'

This Action Plan sets-out the City of Port Adelaide Enfield intentions to strengthen the inclusion and access for residents and visitors. The plan has a particular focus on creating an environment where community members can actively participate in all aspects of community life.

- 'Local Area Bicycle Plan 2015-2020'

The Plan aims to:

- provide an integrated and sustainable transport system that will improve cyclist safety, increase the number of cyclists, connect communities and raise the status of cycling as an enjoyable, respected and legitimate form of transport
- create opportunities for people to safely pursue cycling through the provision of off-road infrastructure, safer street treatments and linear parks, endeavouring to deliver them where physically and economically possible

- 'Long Term Financial Plan'

This Plan has been drafted within the following framework, to:

- remain consistent with Council's current City Plans 2030
- maintain current Council services at their existing service levels
- maintain Council's position as a modest rating Council without compromising its sustainability or the viability of its asset base
- provide for an asset renewal works program over the ten year period to maintain Council infrastructure at acceptable service standards, with no large backlog of required unfunded works
- externally borrow monies to help fund new and upgraded assets

This Plan has been developed with due consideration of the impact of the annual rate charge on the community whilst allowing for the reasonable inflationary impact on Council expenditure in delivering its services and the expected growth of the municipality, and is updated annually.

User fees/charges relate to the recovery of service delivery costs associated with the use of Council facilities.

- ‘Open Space Plan’

To assist Council to make strategic decisions relating to the future provision, development and management of open space within the City and guide Council priorities and support grant funding applications as appropriate.

- ‘Open Space Plan Guidelines’

The Open Space Guidelines provide guidelines relating to open space provision, planning, design, hierarchy and management and aims to assist both Council and developers to achieve quality open space. Open space refers to community land that is available or potentially available to the public for recreation or sport, or has a conservation, aesthetic or buffer purpose.

- ‘White Hollow Reserve Management Plan’

The objectives of the plan are:

- conservation and restoration of existing remnant vegetation
- control and management of high priority weed species
- identification of other threatening process within the project area
- implementation of appropriate revegetation programs to enhance and restore native vegetation
- identification of opportunities for the enhancement of public recreational activities

## **Land identification**

Land designated as passive recreation reserves and subject to this Management Plan is located at various sites within the City of Port Adelaide Enfield and is specifically identified in Appendix 1. Each such site is referred to as “Land” in this Management Plan.

The tenure of the Land and details of any trusts, reservations, dedications or other restrictions affecting the Land is stated in Appendix 1.
