

ABORIGINAL CULTURAL CENTRE PORT ADELAIDE CONCEPT DESIGN OVERVIEW

23.06.2022

We feel incredibly privileged to be afforded the opportunity to support the City of Port Adelaide Enfield Council, AAP, Design Facilitator, and broader Aboriginal and Torres Strait Islander Community to co-create a unique place of connection, learning, and immersive Aboriginal culture on this important site.

PROJECT OBJECTIVES

To establish an Aboriginal Cultural Centre in Port Adelaide with a combination of outdoor and indoor spaces that are designed in an integrated way through strong cultural direction, and that provides space and opportunity for:

- Aboriginal people to gather, learn about and celebrate culture and indigenous knowledge systems, and
- Cultural experiences and learning opportunities for non- Aboriginal people, including school children, local residents and tourists

PROJECT VISION

A place for Aboriginal and non Aboriginal people to learn, experience and be immersed in Aboriginal culture.

A culturally safe place to gather. A place to practice, share, celebrate and record culture past, present and emerging.

A place to connect to Country and culture.

A step in the journey towards reconciliation and an opportunity to strengthen the relationship between the Aboriginal community, Aboriginal Advisory Panel, Council, and broader community.

An opportunity to provide other positive outcomes for the Aboriginal community which align to the priorities identified by the Aboriginal Advisory Panel and Council.

CULTURAL PRINCIPLES

To guide the development of the concept plan, the Council, in collaboration with Brave and Curious and several key Kaurna stakeholders, developed a series of cultural principles. The principles set cultural directions for the design, programming and operation of the project. Importantly, the cultural principles act as key performance indicators to ensure that the concept plan delivers the high levels of cultural representation and expression.

1. Culturally Safe

A locally authentic, culturally safe place.

2. Cultural Immersion

A place to be immersed in local culture.

3. Cultural Practice

To bring back / repatriate cultural ways.

4. Cultural Learning

A place of learning through listening, observation, exploring and doing.

5. Connection to Country

A place to return to Country, foster deep understanding and respect for Country and each other

6. A Place of Healing

Reminded that healing is a shared process-Voice, Truth-telling, Treaty, Justice, Ceremony / Celebration, Walking Together.

THE CO-DESIGN PROCESS

The concept plan has been delivered through an extensive co-design process that has involved authentic engagement workshops with the custodian group and key stakeholders.

Ashley Halliday Architects and WAX sought and were granted permission from the traditional owners to work closely together with the Design Facilitator and knowledge holders to learn about Kaurna Country and the 'cultural landscape' of the site. In exchange we offer our skills and experience in architecture and place-making to assist in the coming together of the physical and the cultural topographies and shaping of the project.

From the start of the design process, the project team wanted to explore the idea of cultural learning. They were keen to avoid the typical hierarchical consultation process of the consultant drawing and design for the community. Instead, by adopting a process of listening and observing, the project team developed an interactive engagement process that used making and doing to explore the potential opportunities.

Using a unique process of physical modelling with kinetic sand, the custodian groups were able to shape the site with their own hands, explore landforms, build mounds, and shape the site's edges. They tested spatial arrangements, coastal edge profiles and discussed how cultural practices and narratives should be expressed, overlaid and embedded into the concept plan.

Over several co-design sessions, the potential of the concept plan was explored. Building on the cultural principles, a series of key design outcomes were developed that steamed directly from the workshops and ideas generated by the custodians during the co-design session. These included;

- Bring water into the site (from the river, over the land and in the ground)
- Creating headlands with views to Lartelare, the river and the hills (connection to Kaurna Country)
- Delivering a shelter and place (setting the building in the landscape)
- Creating shelter to the Women's Area with strong connections to the water
- Elevating the Men's area with protection (shelter for the fire)
- Providing a balance between the Women's Area and the Men's Area (elevation and scale)
- Exploring cultural transitions (public space, protection of cultural spaces, cultural safety)
- Recognising 'flows' across the site (spatial, cultural, spiritual)
- Working with the existing landscape (retaining the trees and mounds)
- Providing protection and shelter for the site (sense of refuge)
- Reinforcing views to Karta, Lartelare and Nganu (frames and viewpoints provide prospect)

CONCEPT DESIGN VISION

To create an immersive Aboriginal cultural experience, where learning, celebration, landscape and architecture are sensitively curated to create a culturally safe, multi-dimensional indooroutdoor place that connects Country and culture.

The Design Concept recognizes and respects Aboriginal connection and on this site the relationship to the land, sea, waterways, and sky. This relationship is crucial to Aboriginal spiritual and cultural identity, cultural vitality and resilience, and further protection of Aboriginal cultural heritage and



knowledge associated with water and water places.

The objectives for the concept plan consider the delivery of the following;

- Cultural events: both indoor and outdoor events and gathering spaces for up to 500 people
- Cultural education: two-way learning for Aboriginal and Non-Aboriginal
- Cultural business: incubation and support of Aboriginal business, education programmes and cultural awareness training (CAT)
- Cultural tourism: development and support of a (Port) Adelaide cultural tourism hub
- Cultural healing: Country and community, truthtelling, memorial, voice, justice, restoring the ecology
- Cultural creative arts: supporting cultural creative arts and music through venues, education, programmes and technical facility
- Family-friendly: welcoming environment for all people of all ages and backgrounds to connect, play and learn














